Announcement regarding the establishment of a subsidiary for the manufacturing of industrial fasteners in Vietnam

1. Purpose of New Company Establishment

Topy Fasteners, Ltd. (Head Office: Mastumoto-City, Nagano, JapanPresident/CEO: Morio Ota), a group company of Topy Industries, Ltd., supplies industrial fasteners such as sheet metal springs and stamping products to a wide sector of industries such as motorcycle and vehicle, electronics, precision mechanical equipment and industrial instrument. Topy Fasteners has achieved great trust from the market for its high quality products and currently holds manufacturing sites in Thailand and the United States as well as Japan in order to respond to customer needs as they expand their international businesses.

Recent rapid economic growths in ASEAN countries have led to expansion in the demand for industrial fasteners. Under such circumstances, demand at Topy Fasteners (Thailand) Ltd., the manufacturing and sales location of fastener products, and stamping products, will exceed the manufacturing capacity. The need for a new manufacturing site to increase capacity has been an important and pressing issue.

Furthermore, manufacturing of motorcycle in Vietnam is expected to increase dramatically from 3,200,000 in 2010 to 4,400,000 in 2014. In response to this growth, Topy Industries Group has decided to establish a new manufacturing and sales location in Vietnam. After start of operation at Topy Fasteners Vietnam Co., Ltd., manufacturing of some motorcycle parts at Topy Fasteners (Thailand) Ltd. will be transferred to the new company. Topy Fasteners (Thailand) Ltd. will mainly increase manufacturing of automobile parts in Thailand, so-called "Detroit of Asia".

With this, the Topy Industries Group will be able to construct a manufacturing and sales system that best suits the features of each country and maximizes profitability in the global market.
